## Action Item

### 1. Presentation and Recommendation on Tuition and Fees

President Barker presented the Administration's tuition and fees recommendation for FY10-11.

The recommendations are as follows:

Undergraduate Student Tuition - In State - 7.5 percent increase

Undergraduate Student Tuition - Out of State - 8 percent increase

Trustee McKissick moved to approve the tuition. Trustee McCarter seconded the motion. The Board approved the tuition and fees recommendation as presented by a vote of 9 to 4.

Graduate Student Tuition - 2.2 percent average

Trustee Britton moved to approve the average increase in graduate student tuition. Trustee McAbee seconded the motion. The recommendation was approved unanimously.

Room and Board - 3.9 percent average

Trustee McKissick moved to approve the recommended average increase in room and board. Trustee Hendrix seconded the motion. The recommendation was approved unanimously.

Cardiovascular Technology Concentration in Public Health - \$200.00 per credit hour

Trustee McKissick moved to approve the recommendation. Trustee Hendrix seconded the motion. The recommendation was approved unanimously.
