MR. SPEAKER AND GENTLEMEN OF THE HOUSE OF REPRESENTATIVES:

I am herewith returning to your Honorable Body House Bill No. 1236, and Act No. 212, introduced by the Richland County Delegation, entitled "TO APPROVE THE ESTABLISHMENT OF DENTSVILLE HIGH SCHOOL DISTRICT OF RICHLAND COUNTY AND TO AUTHORIZE THE BOARD OF TRUSTEES THEREOF TO ORDER AN ELECTION FOR THE PURPOSE OF ISSUING SERIAL COUPON BONDS FOR SCHOOL PURPOSES."
