

PROCLAMATION BY THE GOVERNOR OF SOUTH CAROLINA PROCLAIMING THAT REORGANIZATION PLAN NO. 2, SUBMITTED BY THE STATE REORGANIZATION COMMISSION, PURSUANT TO THE PROVISIONS OF ACT # 621 OF THE ACTS AND JOINT RESOLUTIONS OF THE GENERAL ASSEMBLY FOR THE YEAR 1948, SAID PLAN HAVING BEEN APPROVED BY A CONCURRENT RESOLUTION OF THE GENERAL ASSEMBLY OF SOUTH CAROLINA AT THE 1950 SESSION, BECAME EFFECTIVE ON THE FIRST DAY OF JULY, 1950.

WHEREAS, on the 9th day of January, 1950, the State Reorganization Commission transmitted to the Governor Reorganization Plan No. 2; and

WHEREAS, thereafter, on the 10th day of January, 1950, the said Reorganization Plan No. 2 was transmitted by the Governor to the Senate and to the House of Representatives; and

WHEREAS, on the 2nd day of February, 1950, a Concurrent Resolution, reading "That Reorganization Plan No. 2 be, and the same is hereby, approved by the general assembly of the State of South Carolina," was passed by the House of Representatives, and on the 15th day of February, 1950, the said Concurrent Resolution was passed by the Senate, and the Ayes and Noes were taken and entered in the Journals of the respective Houses, in consequence whereof the said Reorganization Plan No. 2 stands approved by the General Assembly; and

WHEREAS, in and by Act No. 621 of the Acts and Joint Resolutions of the General Assembly of the State of South Carolina, Regular Session of 1948, it is provided that each Reorganization Plan which shall stand approved by the General Assembly shall take effect in all of its terms and provisions on and as of the first day of July next following, and that the Governor shall so declare by Executive Proclamation;

NOW, THEREFORE, I, J. Strom Thurmond, Governor of the State of South Carolina, DO HEREBY PROCLAIM that Reorganization Plan No. 2, entitled:

Reorganization Plan No. 2

Submitted By The State Reorganization Commission Pursuant To The Provisions Of Act No. 621 Of The Acts And Joint Resolutions Of The General Assembly, Regular Session Of 1948, Approved The 20th Day Of February, 1948,

which is herewith filed with the Secretary of State of the State of South Carolina, stands approved on the 15th day of

February, 1950, by the General Assembly of the State of South Carolina, under the provisions of Section 4, Subsection (b), of Act No. 621, of the Acts and Joint Resolutions of the General Assembly of the State of South Carolina, Regular Session of 1948, entitled:

**An Act To Provide For The Reorganization Of The Executive And Administrative Agencies Of The State Government By Transfer, Consolidation, Coordination, Combination And Abolition Of Such Agencies And Functions; To Create The State Reorganization Commission And Prescribe Its Duties, Powers And Functions; And to Make An Appropriation For The Administration Of This Act,**

And that under the provisions of Section 4, Subsection (c), of the said Act, the said Reorganization Plan No. 2 took effect in all of its terms and provisions on and as of the first day of July, A.D. 1950.
