## Exploring changes in campus climate

### Students respond to recent distress.

From student deaths to student led protests to the removal of the Vice President of Student Affairs, the Clemson community as a whole has faced a number of challenges this academic year. Yet through it all, a question that is rarely heard is one that is often the most important: how is the student body dealing with such trying circumstances?

"It's discouraging, quite honestly" said sophomore genetics major Manushi Patel. "Even though you may not know the person who passed away or be involved with the group that feels under represented, it's frustrating to see so many groups of people in pain or conflict."

Clemson's most recent loss came last week with the passing of sophomore Devon Ward. This mournfully marked the seventh student death of the 2014-2015 academic year, a number anyone would consider far too high.

"The loss of seven total students has taken a

great toll on the Clemson family and the student body. My heart breaks for every friend, family member and classmate who has lost a loved one this year," said Undergraduate Student Body President Maddy Thompson.

Compounding these emotional burdens is the cry of minority groups for greater representation among the Clemson community. Students such as senior psychology major Ian Bateman, who heads the group termed "A Coalition of Concerned Students," have been actively protesting since the beginning of December. Their work culminated earlier this month with the presentation of seven grievances and demands on the steps of Sikes Hall. These demonstrations began in response to the Michael Brown court case, escalating with emergence of racially abusive language on "Yik Yak" and the "Crip'mas" party.

Yet some students seem to be unfazed by the conflict. As senior packaging science major and President of the Asian Student Association Nicholas Lor said, "My perception of

Clemson University has not changed at all, even after all the recent happenings around campus. It's still the same campus that provides a great education to its students, and brings the best students from

around the nation to achieve great things."

Still others have even found peace in knowing that there are people on campus who care enough about relevant issues to take a stand.

"I believe that seeing some of the student body stand up for the things that they believe in give me joy. It shows me that there are some people that do actually care about issues that don't

necessarily affect them," said Ian Bateman.

Whatever one's thoughts may be on the events thus far this year, there is no doubt that students are hoping for a quieter, less disputed spring semester.

## Skipping costs

### Students weigh attendance options.

For many students, the first time they are truly on their own is when they head to college. No more "helpful reminders" from mom and dad to get to school on time, to do nightly homework and study for tests. Once students are on campus there is nobody forcing them out of bed or off the couch to get to class each day.

According to Clemson's website, the undergraduate out-of-state tuition adds up to be over \$41,000 a year, whereas in-state students pay over \$23,000 yearly. Depending on how many credit hours undergraduates are enrolled in, the cost per class at Clemson is expensive. Especially for out-of-state students, this is motivation to get up and get to class.

Students such as Hunter Fant, pre-professional health sciences major, hate to miss class. "I try to never miss class, because I feel that when I miss an hour of lecture material it takes me about three hours to make up what I missed." Instead of putting off the work, Hunter feels it is most beneficial to get what she can from class sessions.

For civil engineering major Hagood Hemphill, incentive to go to class is for quality notes. "Most of my professors do not provide notes outside of class, so not only do you hinder your academic success by not going to class and learning material firsthand, but you have to depend on classmates' notes which may not be up to my standards."

Despite all the reasons why Clemson students

should attend class, many kids do not have perfect attendance.

Elizabeth Cox sometimes struggles to venture cross-campus in the winter months. "When it's freezing cold outside sometimes the walk to class seems too daunting, and my bed becomes too warm and cozy to part with." Certain times one more episode of Netflix takes precedence over the 15 minute trek across campus to the lecture hall.

Dr. Darren Linvill, director of basic courses in the communications department, explains how important it is to go to class. "I am not opposed to strict attendance policies." He argues that, "New teachers need to set expectations, and that the attendance policy is the first one that students engage with." By setting expectations with a strict attendance policy, it shows students that they need to respect the course. However, Dr. Linvill added, "Personally, I'm not your dad. College is about becoming an adult and if you don't come to class you're going to fail."

There are other professors at Clemson who instruct courses like business statistics, who see attendance as a strict expectation. In the Statistics 3090 course syllabus it is explained that, "Attendance is mandatory. If you miss more than three days of class you will be dropped." Students will need to plan to make it to class regularly if they want to stay enrolled. Although it may be a struggle to get to class now, attending course sessions will pay off in the future.

## Online learning grows in popularity

### Many seek alternative educational experiences.

Online learning is becoming increasingly prevalent in schools across the country. According to Allen & Seaman, co-directors of The Babson Survey Research Group, a national survey showed that from 2010 to 2013, the number of students enrolled in online courses had increased by almost 1.5 million to around 7 million students. A 2014 report from Allen & Seaman also indicates that more than a third of all college students are taking at least one course online.

Online classes are readily available here at Clemson. Currently, five different master's degrees, two PhD's, and a certificate in early childhood education are offered completely online as well as well over 100 undergraduate courses. According to information from the Clemson Online office, course offerings over the past two years have reached over 160 courses with enrollments reaching almost 5,000. From

July 2013 to August 2014, the number of students who had been enrolled in an online course reached just over 15,000. Since the fall semester of 2009, the number of students exclusively enrolled online has increased by 148 percent.

Director of Online Curriculum and Instruction, Melanie Shaw said, "What is clear is that online education has grown in importance over the past few decades and now makes up a huge part of the curricular landscape in higher education."

Shaw said that contemporary students enjoy the online learning environment and the personalized learning that is available online and that anyone can benefit from online courses.

In regards to the instructor, Shaw said, "Faculty have the opportunity to not only tailor the learning experiences to the student, but meet the needs of diverse learning styles, teaching styles, and learning needs."

Some students feel that

online courses leave them on their own with little assistance, as professors are typically not seen in person at any point during the course. Junior marketing major Erika Mino said that she would prefer a traditional in-class lecture to an online course, because the professors were not very accessible.

Mino said, "We had a lot of questions and they [the professors] didn't really respond."

When asked about who feels that the professors were not easily accessible, Director of Clemson Online Witt Salley said, "That sometimes can be a lack of training of the faculty, a lack of resources needed to deliver effective online education, but if a student is at an institution that values and enforces best practices in online delivery they should feel like they're in a very supportive environment where they are getting even more one-on-one attention, not only from their fellow students but especially from their instructor as well."

Junior management

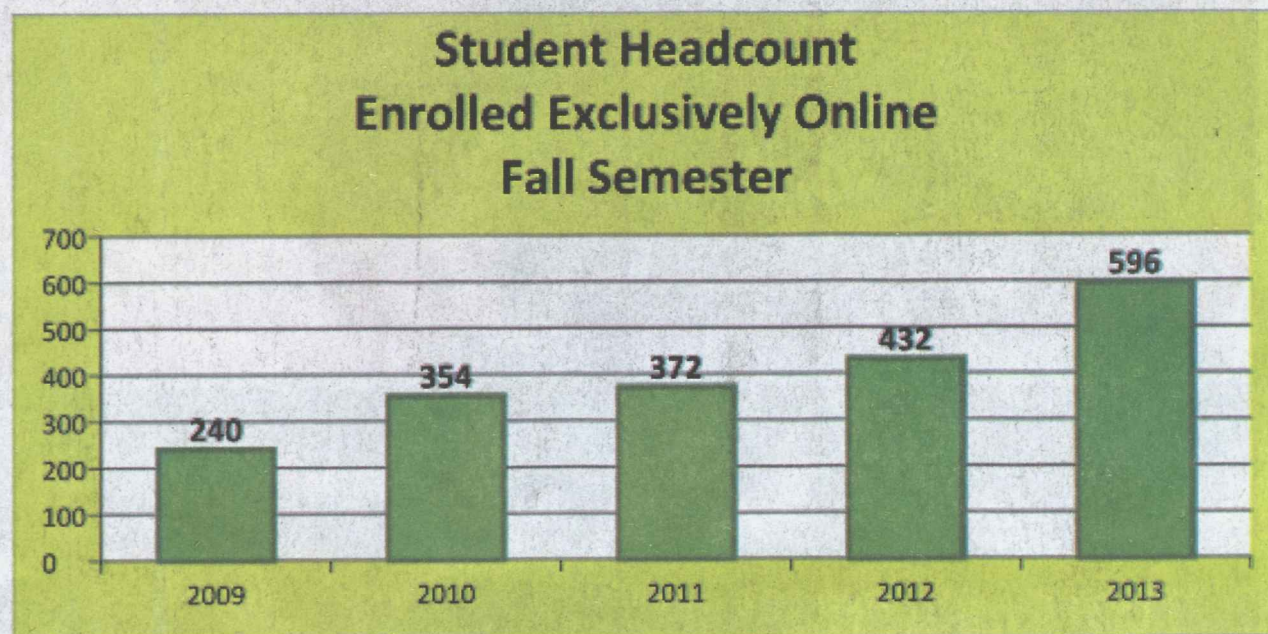
major Jane Baldwin prefers online because of the schedule flexibility.

She said, "I have a very busy schedule, and I work a lot so it gives me the ability to do classes on my own time and make better grades."

Cassie Quigley who currently teaches an online course at Clemson says the hardest part about teaching an online course coming up with innovative ways to get to know the student and for the students to get to know her. Quigley, though, appreciates the opportunity teaching an online course allows.

Quigley said, "It allows for a wider variety to partake in the course. If it weren't offered online, many of my students could be a part of the course."

On the price of the online programs, Salley said, "We don't have a de facto differential tuition for online students, but that is something we are actually exploring right now is should we be thinking about, as an institution, pricing online programs differently than we have done in the past?"

## ROE VS. WADE

As the debate continues between pro-choice and pro-life advocates on whether or not abortion should be legal, the argument should not center on the mother's right, but rather the fetus's rights. What classifies a fetus as a living being? Should it only be considered a life if it can sustain itself outside of the mother's body? Or is it only once it has a beating heart and functioning organs? Why is it that when a pregnant woman is murdered, the murderer is charged with double homicide, but when a woman opts to get an abortion, she emerges unscathed?

Nine weeks, or three months, after conception, a fetus has already developed a brain, spinal cord, heart and other vital organs. Ten weeks after conception, a fetus has eyes, ears, a nose, toes, fingers and other appendages. After just 10 weeks, a fetus already closely resembles a human being, yet Roe v. Wade ruled that an abortion in this stage of life is perfectly legal.

Most recently, Republicans in the House of Representatives have introduced the No Taxpayer Funding for Abortion Act, if passed, that would ban new insurance plans from covering abortion, as well as punish small businesses that choose to buy insurance plans that cover abortion by gutting their tax benefits.

This new bill, as stated by Rep. Steve King (R- Iowa) would prevent federal dollars from being used to fund abortions, thus preventing American citizens from violating their religious freedom by being forced to pay for these procedures.

This bill, which was introduced in January of 2014, has been pulled after Republican Congresswomen decided that rape allowances were too exclusive.

Although this bill has been yanked, on January 19, 2014 the House was successful in passing multiple abortion restrictions that would limit the number of insurance plans that would completely cover the operation. States, such as North Carolina and Texas, also introduced bills that would limit access to abortions, and were met with clear opposition.

These recent bills and laws have provoked an uproar from the Democratic camp, mostly due to the fact that these ordinances are being introduced by men, without giving thought to the female perspective. Although these bills have been shot down, this is still considered progress for the GOP, as anti-abortion laws are quickly gaining ground and popularity.

## Thoughts on Clemson's last-second win over Wake Forest

Free throws and outside shooting woes continue to plague Tigers.

Following a frustrating loss to the Florida State Seminoles last Monday, in which our team shot a measly 52 percent from the free-throw line, the Tigers looked ahead to Saturday's game against the Wake Forest Demon Deacons, hoping to bounce back in ACC competition. It didn't come easy for Brad Brownell's squad, who only led for 24 seconds, but after a well-fought battle, they were able to emerge victorious thanks to a last-second putback by junior Josh Smith.

While it was certainly exciting to hear cheers emanating throughout the rafters of Littlejohn Coliseum after Smith's late-game heroics, I have to admit this game still left much to be desired. I'm not trying to take anything away from this well-earned victory, but the Tigers need to improve on a few things if they want to be a legitimate threat down the stretch to make the NCAA Tournament.

Perhaps it's a bit nit-picky, but the thing I was most disappointed by was our team's lack of progress at the charity stripe. With four days and some change to prepare after the Florida State game, the Tigers still only managed to shoot a mere 55.6 percent. I know nobody is going to make all of their free-throws, but when an opposing team is practically giving you opportunities to beat them you simply have to make them pay for their lack of discipline.

Shooting in general,

for that matter, was a huge problem Saturday afternoon as the Tigers shot 35.1 percent from the field. I know sometimes the shot simply doesn't fall, but our shot selection is just bad at times. It seems that almost one in every four possessions consist of a mind-numbingly high number of swing passes around the perimeter in which someone takes a highly-contested, low-percentage shot from behind the perimeter. Simply said, we make it harder than it has to be.

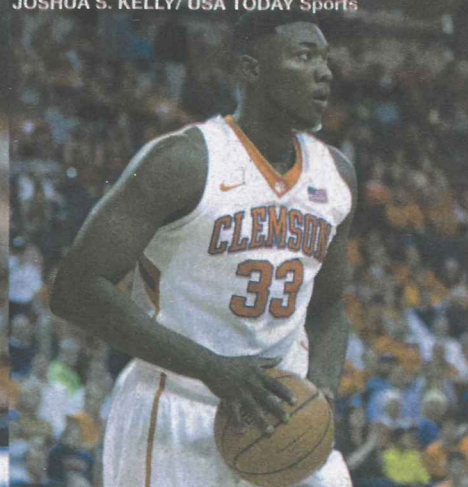
The best remedy to this, is to work the ball inside more. There are stretches during games where our big men don't touch the ball for minutes at a time. Even if we end up not hitting a lot of our inside looks it will at least make the opposing defense play more honest instead of overcommitting on the perimeter (which played a huge role in our 22.2 three-point percentage on Saturday). In short, the Tigers need to become more of an inside-out offense instead of just swinging the ball around the perimeter and settling for bad shots.

Like I said, I'm not trying to bash the home team (I love the Tigers as much as the next guy), but we can't expect to keep winning games if we continue to play the way we did against Florida State and Wake Forest. Hopefully our boys in orange can tighten up some loose ends a bit before taking on the North Carolina State Wolfpack this Wednesday in Raleigh.

## Baseball holds first full-squad practice

Tigers look to rebound after disappointing end to 2014 season.

In just 17 short days, the Clemson baseball team will open their season in the newly-renovated Doug Kingsmore Stadium. While the team earned a somewhat surprising NCAA Tournament bid at the end of last season, the excitement was short-lived, as two straight losses, including an 18-1 blowout by Oregon, knocked the Tigers out of the tourney. However, as the Tigers held their first full-squad practice on Friday, the players and coaches seemed ready to move on and deliver this season.

"Anytime you lose and lose bad like you did at the end of the year last year, it kind of sticks with you a little bit," junior rightfielder Steven Duggar said. "I think everybody had that chip on

their shoulder when they came in this fall. I think a lot of people are ready to get going for sure."

"I don't necessarily look at doubters as people that motivate me," said junior shortstop Tyler Krieger, the team's leading hitter last season, batting .338 with 74 hits, 49 runs and 18 doubles. "I look more towards the people that are behind this program and back us up as supporters. Those people motivate me. I'm happy to play for them and those people — I don't think we have anything to prove. We want to be good. It's not necessarily what we think of other people. I want to be good and everybody on this team wants to be a good."

Fortunately for Head Coach Jack Leggett, five of nine starters are returning, including Duggar, Krieger,

sophomore catcher Chris Okey, senior centerfielder Tyler Slaton and sophomore infielder Weston Wilson. Of those five, Okey led the team in home runs (4) and RBI (41) last season, and Steven Duggar topped his teammates with 25 steals.

On the mound, Clemson returns four starters in juniors Matthew Crownover, Zack Erwin, Clate Schmidt and redshirt senior Jake Long. Together, those pitchers accounted for 46 of 61 starts in 2014, and even though ace Daniel Gossett elected to enter the MLB Draft following last season, the Tigers retained Crownover, who led the team in ERA (2.90), wins (8), innings pitched (99.1) and strikeouts (90).

Despite the disappointing end to the 2014 season, the NCAA bid still marked the 27th time the Tigers had been

selected to the tournament in the last 28 years, and the team looks to have extended postseason success this season.

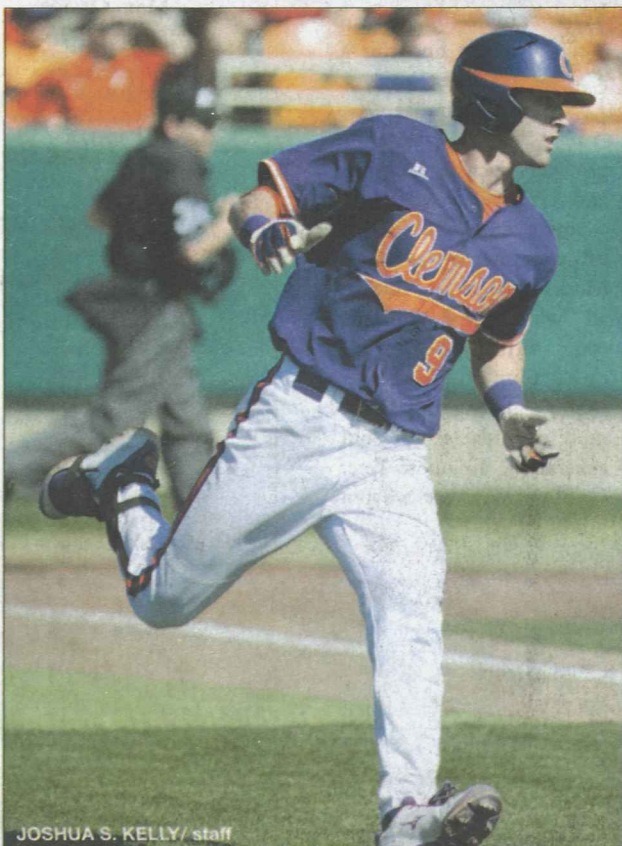
"We have a good mix of players returning with some really great leadership qualities that will make for an exciting 2015 season," Leggett said. "I'm looking forward to a successful season. I'm expecting us to be a really good club. I expect us to compete every single day. I expect us to win. That's our ultimate expectation. We come out and get better every day and I expect a big year."

The Tigers start their 2015 road to Omaha with a home series against West Virginia on Feb. 13-15, followed by home matchups with Charleston Southern, Maine, Wofford and finally rival South Carolina to round out the month of February.

# Lady Tigers fall to Fighting Irish

Clemson women's basketball team now 1-6 in ACC.

The Clemson women's basketball team suffered its sixth straight loss on Saturday with a 74-36 blowout to Notre Dame, the nation's fifth ranked team. The defeat added to a season downturn which has the Tigers sitting at 9-11 and 1-6 in the ACC after what seemed to be a promising start.

Clemson was simply unable to slow the Fighting Irish attack early, as they allowed Notre Dame to go on a 26-4 run, including a stretch of 16 straight, in the first half. Although the Tigers did show some fight near the end of the half, going on a 9-2 run of their own, they trailed by 24 at halftime. In the second half, even with the game seemingly out of reach, Clemson continued to fight and take the

opportunity to improve themselves against one of the nation's best programs.

However, Notre Dame would continue to extend its lead as the Tigers were unable to do much to stop high powered Irish.

Despite the outcome,

there were several positives to be taken from the contest. Most notably, Clemson senior Nikki Dixon scored 15 points (6-17 FG, 3-4 FT) in an effort that would move her up to ninth in Clemson history on the all-time women's scoring list. Even during the losing streak, Dixon has continued to play well and score for the Tigers as she has finished in double digits for all but two games this season.

Clemson also got a strong performance of 8 points and 4 rebounds on a night in which Notre Dame dominated the boards from freshman Cha'nelle Perry. However, evident by Perry and Dixon accounting for over half the Tigers' points, no other players were truly able to make a significant contribution on the offensive end.

Clemson Head Coach Audra Smith stayed positive after the loss and tried to use the game as an opportunity to grow her team's developing skills.

"I tell them that the biggest thing for us is we have to keep fighting, and we did," Smith said. "I have to give credit to Nikki Dixon,

she was fighting for her life. I had to tell the rest of them that they have to match her energy. We have a lot of work to do. I was telling these guys we still can defend, we still can communicate, we can still rebound. There's some areas we can try to continue to work on day in and day out and continue to get better. I was telling these girls that, 'Hey, we're down, but we still can work on the areas that we need to.'"

Smith knows there is still a lot to do to turn the program around and games against teams like Notre Dame are great opportunities for her players to mature.

The Tigers will go on the road to Winston-Salem to play Wake Forest on Thursday. The Demon Deacons (9-12, 0-7 ACC) will provide Clemson with a great opportunity to earn a win and halt the skid.

The No. 22 Clemson men's tennis team had a rough opening weekend falling to both No. 23 Memphis and No. 18 Wake Forest in the Intercollegiate Tennis Association (ITA) Kickoff Event, hosted by Duke University.

The Tigers' first match was a loss against No. 23 Memphis 4-2. Memphis clinched the doubles point against the senior Clemson duo of Hunter Harrington and Alejandro Augusto 6-4. Clemson had little success in the doubles as juniors Austin Ansari and Luke Johnson also lost their matches to Memphis. Sophomore Christian Harris and freshman Hampton Drake's hard-fought match was cut short and ruled a DNF as the doubles point had already been won.

Harrington, ranked 69th nationally, had more success in singles and won a close match against Memphis' Connor Glennon, ranked 79th nationally, 6-4 and 7-5. Ansari also won his singles match by dominating his opponent 6-0 and 6-2. Augusto, Johnson, Drake and sophomore Daffra Sanon all lost their singles matches for the Tigers. The loss dropped the Tigers to 2-1 on the season while Memphis climbed to 1-0.

Clemson's second match was another tough loss against No. 18 Wake Forest 4-1 in a consolation contest in the ITA Kickoff Event. Clemson won the doubles point in this match behind the duos of their No. 1 and No. 3 doubles. Seniors Harrington and Augusto knocked off the Demon Deacons' duo of Mansouri and Seraphim 6-4. Johnson and Ansari were

also victorious for the Tigers, knocking off the Wake duo of Bogaerts and Kan 6-4. Harris and Drake lost their doubles match 6-4.

The Tigers had little success in singles play, losing four out of their six matches, and the other two being cut short for the decision. Harrington, Augusto, Johnson and Drake all lost their singles matches to the opposing Wake Forest players. Ansari and Sanon played tightly contested matches that were both cut short for a decision and ruled a DNF. The second loss of the weekend drops Clemson to 2-2 on the season while Wake Forest improves to 3-1.

Clemson will have a week to regroup after the tough weekend before coming up against No. 29 South Carolina on Saturday, Jan. 31 at 3 p.m.

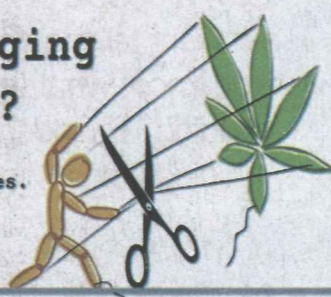

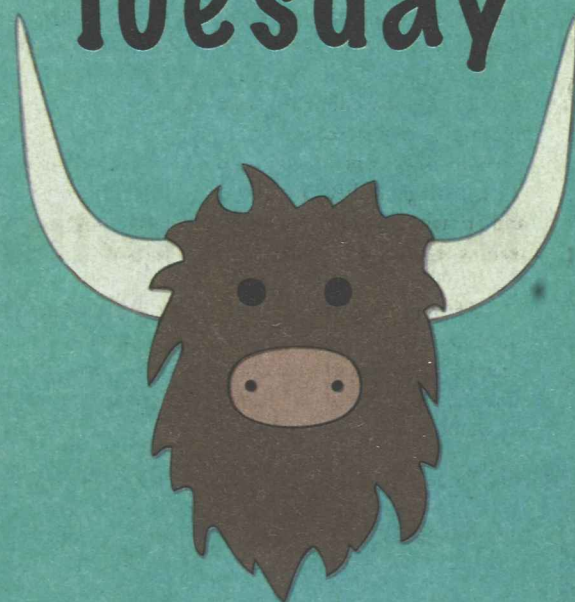

## You Need to See Them

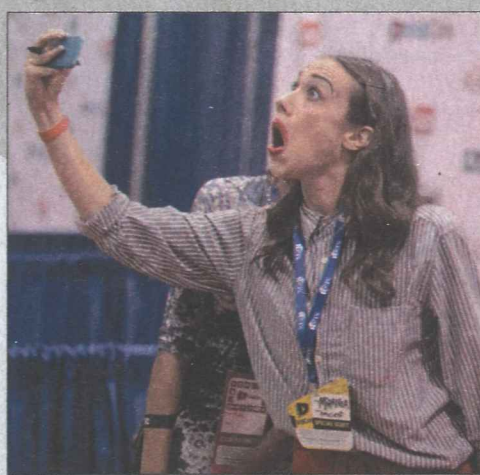

## Collards veggie wrap

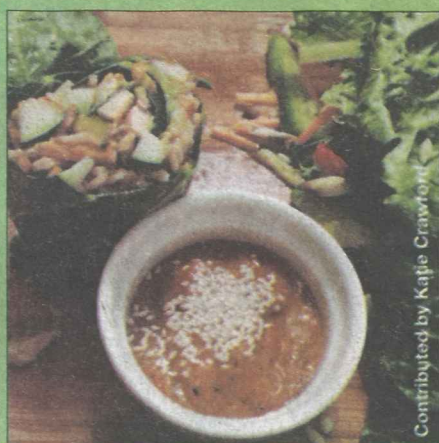

According to Whole Foods, collards are the new kale. I'm not ready to switch collards out for kale completely, but there is something quite versatile about these long stemmed greens. After being inspired by a few too many foodstagram, I decided to try making my own collard spring roll. They are super simple to make, and when putting them on my plate, I felt a little bit like a contestant on Top Chef.

Picking out the perfect curly kale is an art form, as is finding the right collard greens. In the produce section, you'll want to look for medium to large sized leaves. If you have trouble finding them ask for help, but they're usually near the kale.

### Ingredients for the sauce:

1 red bell pepper  
1 mango  
Fresh cilantro  
Sriracha  
Sesame seeds

### Ingredients for the wrap:

Large collard greens  
Brown rice  
Carrot shreds  
Mushrooms  
Cucumber  
Mixed bell pepper  
Onion  
Tofu and black beans if desired

To make the collard more flexible, cut the center stem in an upward motion while keeping the knife parallel. After de-stemming the collards, fill them with whatever you'd like! I filled mine with mostly veggies, but I've also added tofu and black beans to the mix.

The best part of this recipe is the sauce. The ingredients sound odd, but once blended it becomes a spicy, sweet and savory concoction that you'll want to start putting on everything. Dice the bell pepper, mango and cilantro. Blend all ingredients in a high-powered blender (I use a Magic Bullet) until creamy. Depending on how much flavor you like, add cilantro and Sriracha sparingly and add more if needed to taste. I like my food so spicy that it brings tears to my eyes, so I added quite a bit of each.

After putting your desired toppings in your wrap and adding the mango cilantro sauce, start to roll tightly. If you've ever made sushi, the technique is similar. After the wrap resembles a long nori roll, cut in half. For even spicier mango deliciousness, dip the wraps in the sauce. Enjoy all the yummy and messy goodness that will ensue.

This type wants to be in a relationship, but can't because they are emotionally stunted and socially inept. They might also:

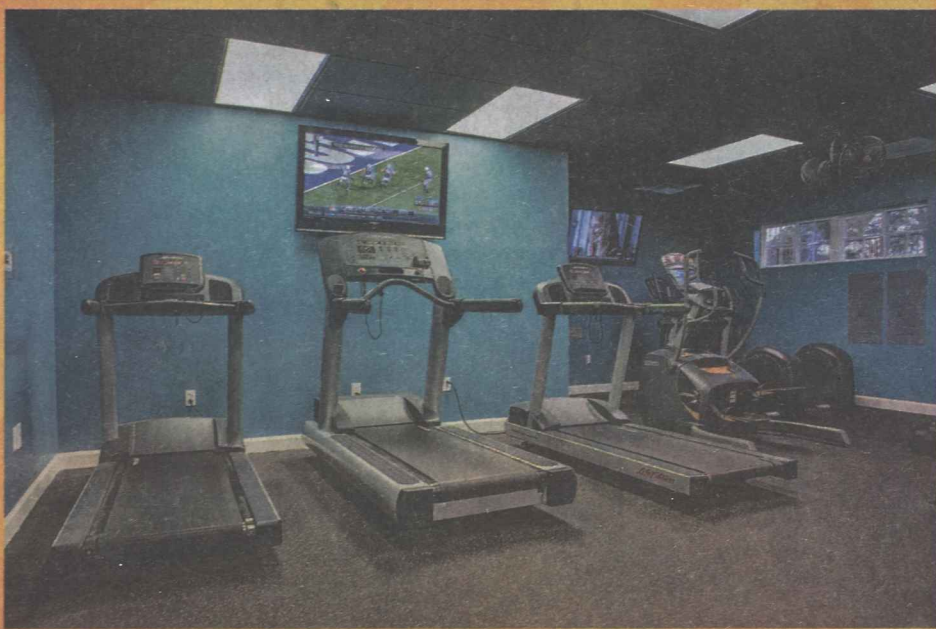
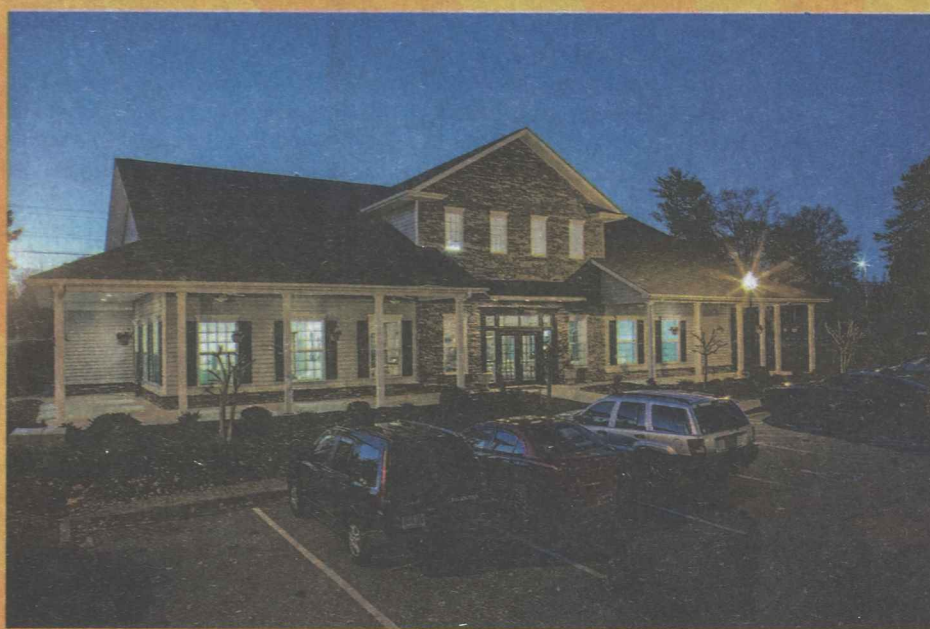
